What this form is for

This application form is for the licensee of certain on-premise or small bar licences who apply for a take-away sales authorisation to sell liquor by retail for consumption away from the licensed premises (except on Good Friday and Christmas Day).

Note

A take away sales authorisation that applies to an on-premises licence can only be granted if:

- a) the licence is held by or on behalf of a non-proprietary association and the premises promotes tourism or industry in the local area in which the premises are situated, or
- b) the licensed premises are situated in or on a facility that is under the control or management of a public authority.
- c) a restaurant

A public authority includes:

- a statutory body representing the Crown, including a NSW Government agency – Interpretation Act 1987, section 13A applies
- a Council within the meaning of the *Health Practitioner Regulation National Law* (NSW), Part 5A.

Cost

The fee for this application is set out in the Liquor Fee Schedule.

If the application is withdrawn or not granted, licensing fees can be refunded, however processing fees are non-refundable.
