What you need to know

- This form is for an individual or organisation who organises an industry show or producers' market/fair.
- This notification allows producers of wine, cider, perry or mead, beer or spirits to:
 - conduct tastings,
 - sell or supply liquor at the event for consumption off premises.
- There is no minimum number of stall holders displaying their produce required for an event.
- An industry show means a wine, beer, spirits or other liquor show at which liquor products are promoted and is being held by an industry association.
- A producer's market/fair means an event primarily held to promote and sell produce from either:
 - the hospitality industry, or
 - a particular region.
- **No payment is required.**
- Lodge the notification with the Independent Liquor and Gaming Authority (ILGA), NSW Police and the local consent authority at least 7 days before the event. You can use a copy of this form for notification to police and the consent authority.
